ATTENDANCE POLICY & TIME COMMITMENT: Since Coro's learning methodology is experiential and cohort-driven, missing sessions is both disruptive to your learning as well as the other program participants'. We recognize that unanticipated scheduling conflicts can and do arise. Therefore, *Coro allows up to a total of two (2) program day absences.* Due to the significant amount of content covered and the foundation laying for the program and cohort's development, *attendance at Session 1 is mandatory*. If any applicant has significant scheduling conflicts for the program dates, they should speak with Coro prior to applying to determine if accommodations can be made. If a participant accuese more than the allowed number of program day absences, they may be asked to leave the program. Based on past program participant feedback, it is best to consider programing as an extension of your professional responsibilities and to place calendar holds for all program session dates and times at the time of applying and to begin speaking with your employer/supervisor(s). *Participants can expect about 5-10 hours of additional time spent outside of scheduled sessions on Coro Conversation team planning and minimum pre- or post-program session assignments.* 

\*COVID-19 POLICIES & VIRTUAL MODE: Coro is committed to ensuring the public health of our participants and community; all WLN participants will need to provide proof of full COVID-19 vaccination and public health recommended COVID-19 boosters. Additionally, all participants will need to review and acknowledge via signature the COVID-19 Guidelines of Conduct for Participants, COVID-19 Waiver of Liability, and COVID-19 Vaccination Policy. In case the County of Los Angeles Department of Public Health or relevant public health department/agency provides public health guidance or rules that limit the ability of in person programming due to the continued impacts of the COVID-19 pandemic, the program will switch to virtual delivery. In this event, the session dates and times will remain the same and the program facilitator will communicate adjustments to the schedule. Participants will be given notice as well in advance as able. WLN participants should be prepared to **sequences**. In the event of virtual delivery, participants will need access to Zoom, GSuite, and a stable internet connection. If virtual delivery becomes necessary and these latter requirements poise any issues, please contact Coro so that we can make suitable arrangements to ensure your successful participation.
