

# **Youth Fellows Program Application Guide**

The Coro Youth Fellows is an immersive, experiential, cohort-based summer program that trains high school participants in leadership skills needed to be effective and to understand how local civic systems work. This year the program will be primarily in-person with some virtual elements. Visit corola.org/YFP for more information.

## **Eligibility**

- Current High School sophomore or junior
- Able to attend the entire 6-week summer program
- Able to return phone calls and emails in a timely manner
- Able to secure consistent transportation to Coro activities and internships
- Payment of program tuition, \$5,000, or scholarship award (need based scholarships are available, please see the details below)

### **Application Information**

**Please Note:** The application must be completed in one sitting. We highly recommend working on and saving the essays in a separate document so that you can paste the text into the application without the risk of losing content. If you are requesting financial aid, please complete the application with a parent/guardian nearby, as you'll be asked to provide financial information in the last section of the application. **Applications are due 11:59pm PST April 7, 2024.**

#### **Section 3: Essay Questions**

- 1. Tell us who you are. You can describe your background, values, significant experiences from your past, and/or special hobbies/interests that have helped to shape your identity, values, and/or aspirations.
- 2. What is the most challenging obstacle that you have had to overcome? Discuss the impact it has had on you and what you have learned from the experience.

#### **Section 4: Video Testimonial**

Upload a 60-second video testimonial answering the following question: What are your reasons for applying to the Coro Youth Fellows Program? How will you apply your leadership training in your school or neighborhood community?

- Video should be one single cut with just the applicant, in a quiet space, direct to the camera.
- The video should feature your head and upper torso.
- Please begin the video by stating your full name.
- Business professional attire is strongly encouraged.
- We recommend that you test your audio and lighting to ensure clarity of sound and video.

#### **Section 5: Interests and Skills**

This section is an opportunity to share your interests and skills with Coro, to better match you with your field placements. Your application will **not** be affected by whether or not you have any of the skills listed in the questions.

#### **Section 6: COVID Regulations**

Youth Fellows participants must be fully vaccinated against COVID-19 in order to participate in the program.

#### **Section 7: Financial Aid Application (Optional)**

Should be completed with a parent/ guardian who will be asked to provide details from their 2022 and 2023 Federal Income Tax Returns as well as a brief description of the household's current financial situation.

#### Recommendation

Please ask a teacher, counselor, coach, supervisor, etc (no family/ friends) to fill out our online Recommendation Form on your behalf. The Recommendation Form can be found <a href="here">here</a> and must be received by **April 7, 2024.** Applicants are responsible for confirming this submission with their recommender.
